

AWARDS OF EXCELLENCE 2010

Lifetime Achievement Award Criteria

Vancouver Regional Construction Association invites construction firms or any two individuals directly involved in the construction industry to nominate an individual for recognition at the VRCA's Awards of Excellence evening for the **"2010 Lifetime Achievement Award"**

Terms of the Award

- To be eligible, nominees will have displayed the qualities of a leader who applies the highest standards and principles of the construction industry and the business community in pursuit of leadership and excellence in any field that serves the construction industry. The nominee's qualifications may result from contributions in the year the nomination is advanced, or over a period of several years.
- Nominees will have given much in the way of volunteer time and effort to association activities, being an ambassador through promotion of the image and profile of the industry and association.
- Nominations for this award may be submitted by a construction company or any two individuals directly involved in the construction industry.
- Eligible nominees must be a member of VRCA whose career employment is in the construction industry. VRCA Life Members shall be eligible for the award.
- Employees of associations or other groups peripheral to, but not actively involved in the construction industry, will not be eligible for this award.
- All submissions in support of a nominee for this award become the property of the Vancouver Regional Construction Association.
- A committee of three members of the Vancouver Regional Construction Association who are active in the construction industry will judge nominations. The Chair of the VRCA will appoint members to the awards committee.
- The Chair of the association shall not be eligible during the year in which she/he holds such position.
- To be eligible, nominations must be submitted on the prescribed form. Submissions should include a one page (maximum) point-form description outlining why this person is being nominated and a brief biography.
- The award shall not be presented in any year in which, in the opinion of the judges, no suitable candidate has been nominated.
- The decision of the awards committee shall be final and not subject to appeal.
